***Landlord/Renter Policy:**

Landlord pays a one-time non-transferable deposit per above schedule that is placed on hold. When the tenant discontinues service, the account reverts (no transfer fee) to the landlord, who pays the availability charge (minimum monthly bill) or usage charge until there is an account established for the next tenant.

The undersigned hereby makes application for water service at the above address and agrees to pay for said service as measured by the City's meter according to rate applicable.

The applicant agrees to permit authorized agents of the City free access to the premises of the consumer for the purpose of inspecting, reading, repairing or removing property of City.

The City shall have the right, but not be obligated to inspect any installation before water service is introduced, or at any later time, and reserves the right to reject any plumbing not in accordance with City's standards; but such inspection or failure to inspect or reject shall not be regarded as an insurance against defects in installation, and shall not render City liable or responsible for any loss or damage resulting from defects in the installation, or from violation of the City's rules and regulations or from accidents which occur upon customer's premises.

The applicant agrees that this application is subject to the City's Rules and Regulations, a copy of which is open for inspection at the office of the City, and that these Rules and Regulations are a part of this agreement.
