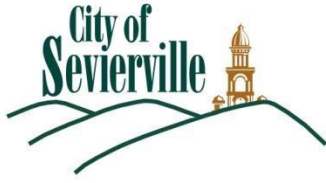

Mr. Pinkham made a motion to approve the sign, which received a second from Mr. Tarwater. The motion passed unanimously.

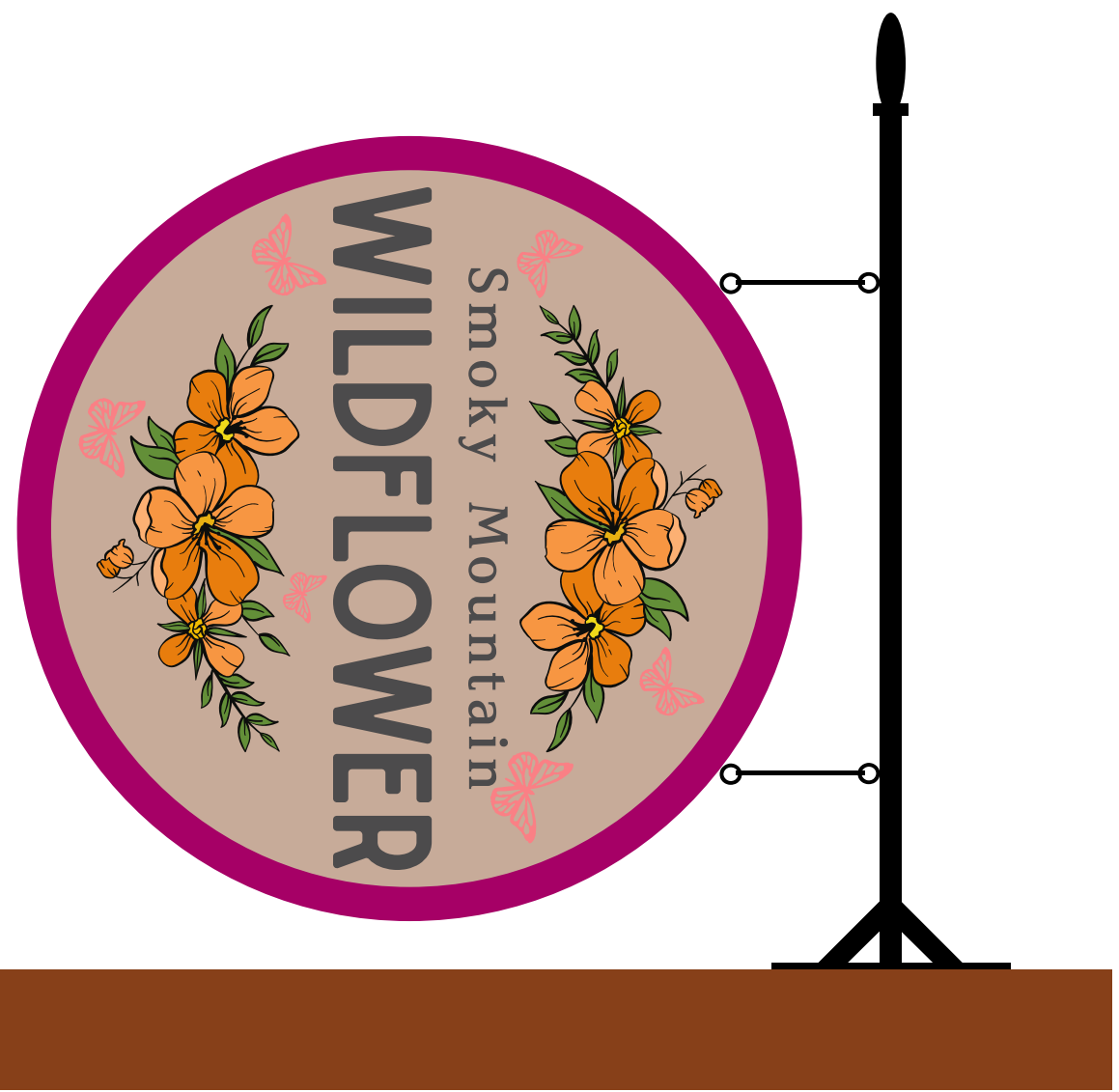
ADJOURNMENT
