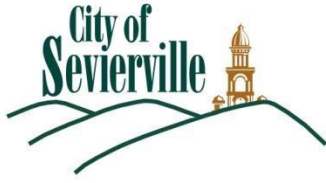

NEW BUSINESS

DETERMINATION ON CONTRIBUTING BUILDING STATUS FOR THE PINES – 103 JOY STREET.

Mr. Smith reminded the commission that they granted this project received façade approval at the May meeting. Most of the remodeling has been completed as originally proposed, with only the jut-out awning sign lacking. He presented the criteria for buildings to receive the Contributing designation and the commission reviewed current photos of the structure.

Action Taken

Mr. Pinkham made a motion to grant contributing status to The Pines building. The motion received a second from Mr. Tarwater and passed unanimously.

TROTTERS WHOLE HOG BBQ REQUESTS RATIFICATION OF SIGN – 127 BRUCE STREET.

Mr. Smith explained that the applicant installed the sign, assuming approval was included in a previous approval for this location. The façade approval granted by the commission at the September 2020 meeting did not include the sign, therefore ratification is needed. The commission reviewed both the renderings and photos of the existing sign.

Mr. Duncan made a motion to ratify the sign proposal. The motion received a second from Mr. Bradley and passed unanimously.

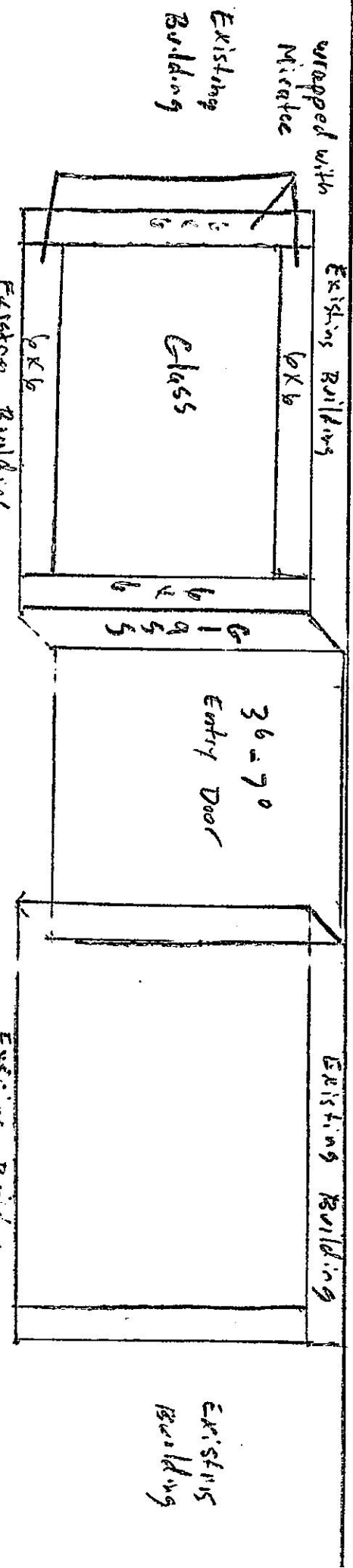
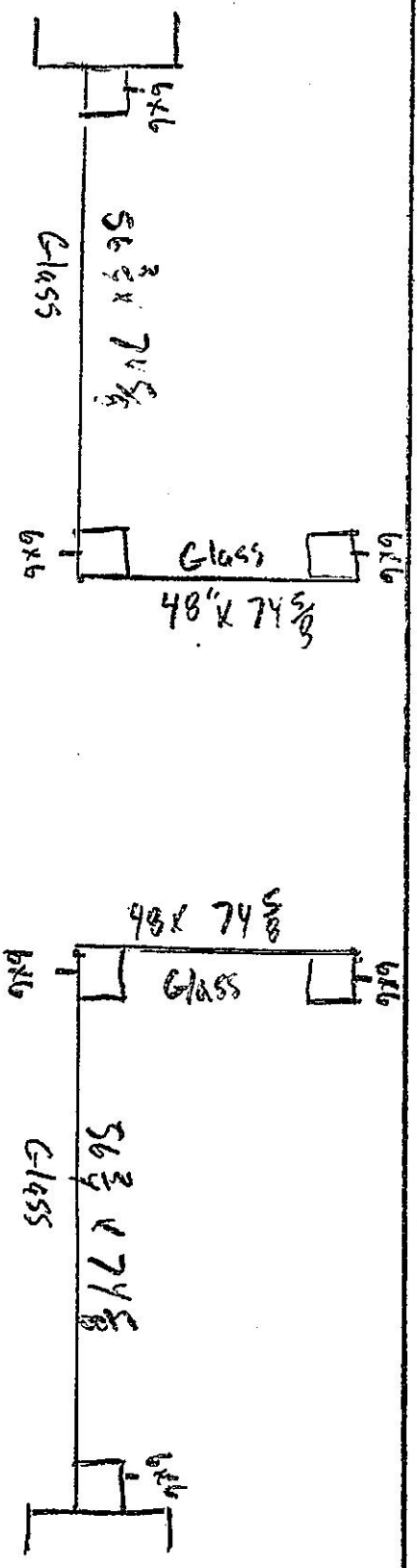
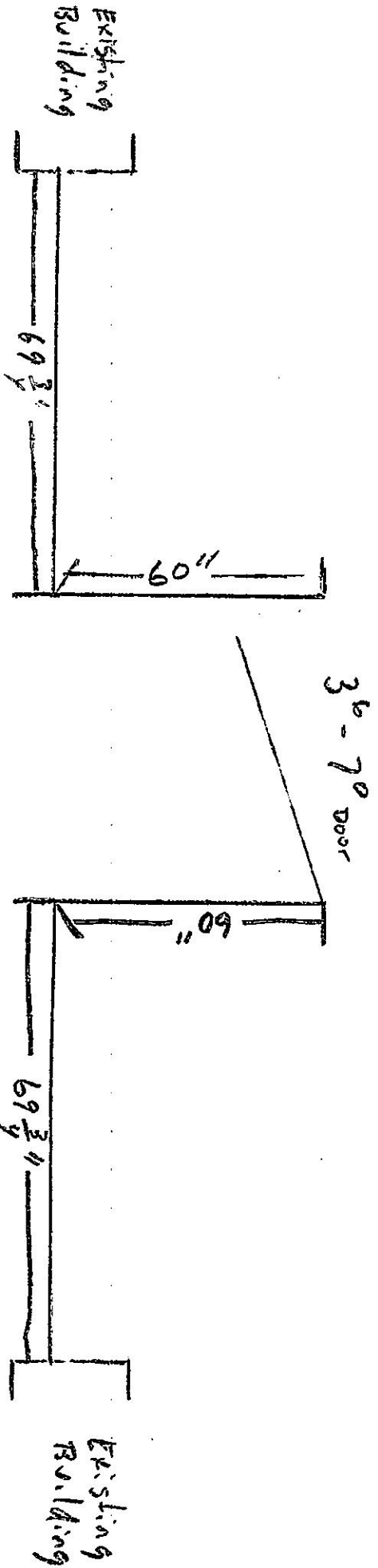
There being no further business, the meeting adjourned at 4:34 PM.
